

**YOUNGSVILLE BOROUGH  
WARREN COUNTY, PENNSYLVANIA  
ORDINANCE NO. 527**

AN ORDINANCE AMENDING ORDINANCE 264 AS PREVIOUSLY AMENDED BY ORDINANCE 519, 496, 491, 479, 478, 473, 471, 448, 432, 429, 415, 409, AND ORDINANCE 394, SAID ORDINANCE 264 PROVIDING FOR THE REGULATION OF THE MANNER OF COLLECTION AND DISPOSITION OF REFUSE WITHIN THE INCORPORATED LIMITS OF THE BOROUGH OF YOUNGSVILLE, WARREN COUNTY, PENNSYLVANIA.

BE IT ORDAINED AND ENACTED, by the Borough Council of the Borough of Youngsville, and it is hereby ordained and enacted by Authority of the same, that Ordinance 264, as heretofore amended by various Ordinances of the Borough as more fully recited above and most recently by Ordinance 491, 496, and 519 be amended to read as follows:

SECTION I:

On and after the 1<sup>st</sup> day of January, 1998, the following schedule for residential disposal shall be effective:

	<u>Disposal Rates</u>
Family or Single Person	\$51.00 per quarter year
Senior Citizen (Couple or Single)	\$37.00 per quarter year
Apartment Units	Paid by Owner and based on number of apartments and the number of containers

Disposal rates are herein set, requiring all Residents and Businesses to pay the rate established.

A senior citizen is herein defined to be someone of age 62 or older, and a senior couple is defined to be a household wherein one of heads of the household is age 62 or older.

Extra cans/bags will be charged at the rate of \$1.50 per can/bag and added to the regular bill. Heavy items (defined herein to include appliances, stoves, furniture and items not handled during the regular garbage pick-up) will be treated as extra pick-ups at the rate of \$5.00 to \$100.00, according to weight.

SECTION II:

On and after the 1<sup>st</sup> day of January, 1998, the disposal rate per quarter for businesses shall be based upon volume and/or weight as follows:

	Cans/Bags	Dumpster
Business / Industrial	\$51.00 2 cans/bags pick-up 2 times per week	\$70.00 dumped once per week
	\$10.20 for additional can/bag per pick-up	\$130.00 dumped 2 times per week \$60.00 per additional dump

Residential customers are in addition to business rates where residence are together.

SECTION III:


Payment for all services is due upon or before the 15<sup>th</sup> day of the month following the date of issuance of the billing statements. Statements unpaid after the said 15<sup>th</sup> day of the month following date of issuance shall be subject to a late charge in the amount equal to five percent (5%) of the amount due. Accounts unpaid after the expiration of the 30<sup>th</sup> day of the month following the issuance of the account statement shall be subject to service cancellation by the Borough in accordance with its applicable Ordinance and Regulations.

SECTION IV:


Any Ordinance or part of Ordinance inconsistent with this Ordinance is hereby repealed.


